About 80 such factories were closed down after the Ministry of Environment and Forests (MoEF) had decided days ahead of the Lok Sabha elections last year that they needed to take environment clearance (EC); it was nothing but harassing and making people unemployed. This was without any court order or any expert committee's recommendations.

After the new government assumed power, MoEF looked into the matter and took the decision that those factories should not be closed till they get EC.

Similarly, 6,000 km of border roads and strategic defence infrastructure within 100 km of line of actual of control were required to get EC. However, MoEF decided to give a gener-

al approval for all defence projects. We must save the nation to save the environment. However, that does not mean they (companies) will be allowed to recklessly fell trees. They will have to follow the standard guidelines.
